The Compact Reader

Here is a book for composition instructors who find that the standard-length rhetorical reader, costing anywhere from ten to fifteen dollars, provides many more essays than they need and obliges students to pay for much more than they read. In contrast, *The Compact Reader* offers a smaller selection of essays (26) at a smaller price (\$6.95)—but with editorial apparatus rivaling or surpassing that of every other rhetorical reader on the market. Thus instructors can cover most of the essays in this book and still have time for other activities, while students get the rhetorical information and clear models they require—and their money's worth.

Student Writers at Work allows instructors to work with student writing in ways never before available to them in book form. It presents 31 winners of Bedford Prizes in Student Writing, the nationwide contest to find the best essays written for a freshman composition class in 1982.

There are also four unique chapters designed to help instructors working with their own students' writing.

1. "Students on Writing," the book's general introduction, provides an overview of the writing process by listening to the winning essayists talk about their writing successes and failures.

2. "Two Student Writers at Work" reprints the preliminary notes and complete drafts of two of the essays along with comments of the student writers explaining their intentions.

3. "Peer Editors at Work" explains the procedure of peer editing, annotates one of the essays with the comments of students experienced in peer editing, and then shows how the student writer further revised her essay in response to these comments.

4. "The Professional Editor at Work" presents two of the essays as edited by a professional editor and then as revised in response to her suggestions.
